1. The purpose of this Circular is to inform all users of the Merchant Marine Directorate that we have developed a new Online Verification, through which you will be able to search and verify the validity of the following Certificates:

- International Ship Security Certificate (ISSC).
- Continuous Synopsis Record (CSR).
- Armed Personnel Authorization.
- International Ballast Water Management Certificate.
- Ballast Water Management Plan (BWMP).
- Civil Liability for Bunker Oil Pollution Damage (BCC).
- Declaration of Maritime Labour Compliance (DMLC Part I).
- Liability for the Death and Personal Injury to Passengers (PAL).
- Liability for the Removal of Wrecks.
- Company Security Officers (CSO).
