1. The purpose of this Merchant Marine Circular is to inform all the users of the Panamanian Registry the instructions for the payment of the Continuous Synopsis Record (CSR), International Ship Security Certificate (ISSC) and SSAS Exemption Certificate.
 2. In accordance with Resolution J.D. No. 028-2022 of June 14, 2022 and published in the Official Gazette 29,607-B of August 25, 2022, the above certificates should be requested at our Headquarters in Panama, through any authorized General Consulate of Panama or at any of the Segumar Offices listed in paragraph 4, a fee of Fifty Dollars (USD50.00) will be applied per certificate plus the regular cost established by MMC-183, MMC-359 and MMC-123. These certificates will be send via email to the office where you applied. The fee will be effective from **September 25, 2022**.
 3. Please be sure to submit the receipt with the total amount for the issuance of the mentioned certificate through the following website link <http://certificates.amp.gob.pa/certificates>.
