- 1. With the purpose of providing a better service to all our users, we kindly request that payments to the Segumar- Miami account, and Panama local bank account through bank wire transfer (electronic payment service for transferring funds by wire), include at least the following information:
 - Name of the Ship;
 - IMO No.; and
 - Certificate (s) that is being paid.
- 2. In case of payment for several ships and / or certificates, kindly send a separate list to accounting@segumar.com in case of payments to the international bank account or recaudos@amp.gob.pa in case of payments to the Panama local bank account, along with copy of the bank transfer.
- 3. Customers are kindly advised before payment is made, to verify with your local bank and intermediary bank, the applicable fees for international wire transfers that will be charged so as deducted fees from the amount of the wire transfer do not affect the full payment for service requested.
- 4. In addition to the regular cost of the requested Certificate(s), we are asking to our customers to cover the amount of US \$50.00 as fee for international wire transfer in order to avoid receiving incomplete payments.
- **5.** The remitter should include the code "OUR", when sending wire transfers.
- 6. The measures mentioned are aimed to improve the quality of our services and the satisfaction of our customers.

- 8. In addition to each Certificate regular fee, from 25 September 2022, an additional charge applies for reviewing and handling documentation of fifty dollars (USD 50.00), for the issuance of any other technical certificate duly authorized by the General Directorate of Merchant Marine or through any SEGUMAR Office in a Merchant Marine Consulate, including the SEGUMAR offices in the State of Florida, the United States of America based in the city of Miami and SEGUMAR Head Office. additional charge applies for the issuance in Panama, of technical certificates by the

General Directorate of Merchant Marine. This charge shall be reflected in the official receipt, as fees for this service. (Resolution J.D. No.028-2022 dated 14 June 2022).
