  - **4.2.** registered owner shall be the same indicated in the registry certificate. In case of C/O this may also be included. For MLC 2006 "shipowner" as defined by the Convention is accepted on the correspondent financial securities.

- **9.8.** A statement from an independent and internationally recognized rating agency in relation to the rating of the Insurance Company and/or reinsurers, duly authenticated and/or apostilled;

- **10.** Blue Cards or Financial Securities shall be reissued by the P&I Clubs, insurance companies or financial security providers due to change of ship's, shipowner, gross tonnage (for WRC 2007) and any other reasons; therefore, previous Financial Securities shall be cancelled as well as the correspondent Certificate (if one exists).
