Merchant Marine Circular No. 160

To: Owners/Operators of Panamanian Ships, Recognized Organizations, Masters of Panamanian Flag Vessels.

Subject: Qualifications, training and experience of the Designated Person

Reference: International Management Code and Revised Guidelines on Implementation of the ISM Code Amended by Resolution MSC.179(79) - International Safety Management (ISM) Code Resolution A.741(18) Amended by Resolution MSC.104(73) - Part A - Implementation – 4 Designated Person(s); MSC-MEPC.7/ CIRC.6

- 1. To ensure the safe operation of each ship and to provide a link between the company and those on board, every company, as appropriate, should designate a person or persons ashore having direct access to the highest level of management.
- 2. Considering that the Designated person has a key role in the development and implementation of the safety management system within a shipping company with a view of ensuring safety at sea, prevention of human injury, loss of life, damage to the environment, in particular to the marine environment, the International Maritime Organization has provided guidance on the qualifications, training and experience for undertaking the role of Designated Person under provisions of the International Safety Management Code.
- 3. Taking into consideration these guidelines, this Administration encourages shipowners/operators of Panamanian flag vessels to comply with the following:
- 4. Designated Person should have a minimum of formal education as follows:
 - 1.Qualifications from a tertiary institution recognized by the Administration or by the recognized organization, within a relevant field of management, engineering or physical science, or
 - 2. Qualifications and seagoing experience as a certified ship officer pursuant to the International Convention on Standards of Training, Certification and Watchkeeping for Seafarers (STCW), 1978, as amended, as amended on 1995, or
 - 3.Other formal education combined with not less than three years practical senior level experience in ship management operations.

- 4.Designated Person should have undergone training relating to safety management elements in compliance with the requirements of the ISM Code, particularly regarding:
- 5. Knowledge and understanding of the ISM Code;
- 6. Mandatory rules and regulations;
- 7. Applicable codes, guidelines and standards as appropriate;
- 8. Assessment techniques of examining, questioning, evaluating and reporting;
- 9. Technical or operational aspects of safety management;
- 10. Appropriate knowledge of shipping and shipboard operations;
- 11. Participation in at least one marine-related management system audit; and
- 12. Effective communications with shipboard staff and senior management.

5. Designated Person should have experience to:

- 1.Present ISM matters to the highest level of management and gain sustained support for safety management system improvements;
- 2.Determine whether the safety management system elements meet the requirements of the ISM Code;
- 3.Determine the effectiveness of the safety management system within the Company and the ship by using established principles of internal audit and management review to ensure compliance with rules and regulations;
- 4.Assess the effectiveness of the safety management system in ensuring compliance with the other rules and regulations which are not covered by statutory and classification surveys and enabling verification of compliance with these rules and regulations;
- 5.Assess whether the safe practices recommended by the Organizations, Administrations, classification societies, other international bodies and maritime industry organizations to promote a safety culture had been taken into account, and
- 6.Gather and analyze data from hazardous occurrences, hazardous situations, near, incidents and accidents and apply the lessons learnt to improve the safety management system within the Company and its ships.
- 6. The Company should provide training courses covering qualifications, training and experience and the appropriate procedures connected to compliance with the ISM Code including practical training and continuous updating. The company should also provide documentary evidence that the Designated Person has the relevant qualifications, training and experience to undertake the duties under the provisions of the ISM Code.
